

NEW LAW ADOPTED IN DECEMBER 2017

- - MOST OF PROVISIONS OF THE NEW LAW ARE IN BREACH WITH POLISH CONSTITUTION AND EUROPEAN STANDARDS (the process of election of new members of NJC, lowering the retirement age for S.C. judges, etc.)
- EXECUTIVE POWER ENSURES IT'S TOTAL CONTROL AND SUPERVISION over the disciplinary proceedings
